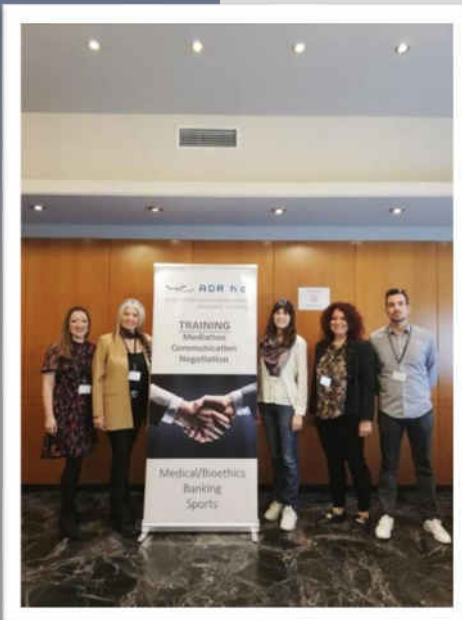

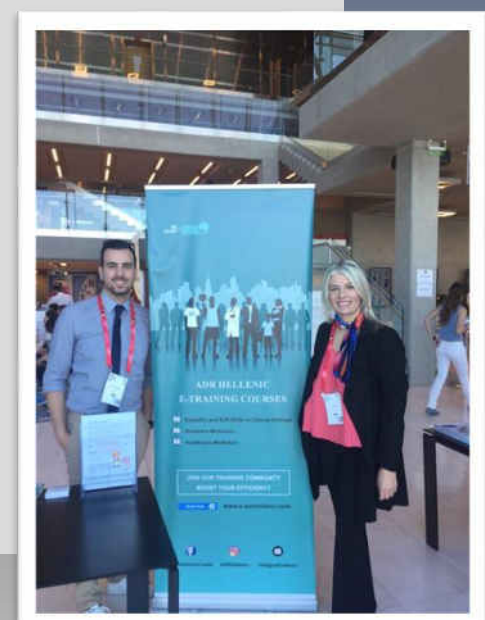

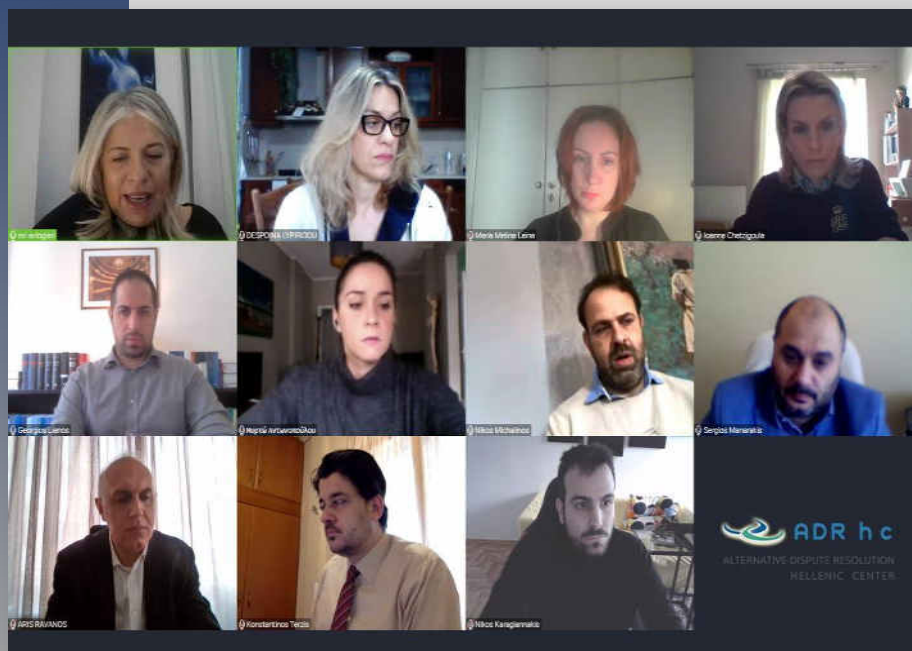
Medical and Bioethics Mediation

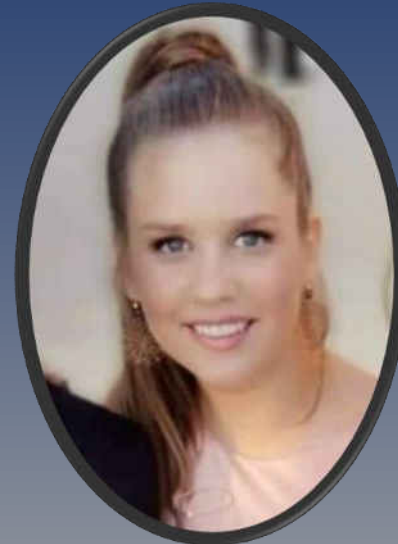
